

# New regulations for primary distribution boxes



## Overview

Regulation (EU) 2025/40 on Packaging and Packaging Waste (short: PPWR) came into force on February 11, 2025, and will apply directly in all EU countries after a transition period of 18 months, starting on August 12, 2026. On February 11, 2025, the most significant packaging legislation in three decades officially entered into force across the European Union. The Packaging and Packaging Waste Regulation (PPWR) – Regulation (EU) 2025/40 represents a fundamental transformation in how packaging is designed.
