Open Fiber, tasked by Italy 's government almost a decade ago with rolling out fibre optic cables across the country, is 60% owned by state lender Cassa Depositi e Prestiti, with the rest in the hands of Australian fund Macquarie. With nearly 28 million kilometres of fibre optic cable already laid – a distance equal to more than 700 times the Earth's circumference – and ultra-broadband coverage reaching over 96% of active lines, the. FiberCop is the company managing the most advanced, extensive, and capillary digital network infrastructure in the country, with more than 25 million kilometres of fibre optic cable already built and available to operators and an ultra-wideband coverage of more than 95 per cent of active lines. Subsea cable manufacturing firm Xtera has been acquired by a pair of Italian companies. Late December saw a joint venture from Prysmian and Fincantieri sign an agreement to acquire Xtera Topco Limited, a UK and US-based leader in turnkey submarine telecom systems, from an affiliate of H. FiberCop was spun-off from TIM in July 2024, when a KKR-led consortium completed an 18. 8-billion-euro buyout of the unit.
